2008 National Convention, Louisville, KY September 7—11, 2008: Recap:

Sept 7th-9th (registration/credentials); also exhibit tables opened.

Sept 8th—Call to colors by the **Dr. V. Edwards Master Memorial Color Guard, Sons of the American Revolution**; delegates were led in singing of the National Anthem by the **3 Mauldin Sisters of Louisville**. Memorial Service led by **Jan Ceella of the Kentucky Federation**. **Continued on top of next col.**

2008 NARFE National Convention continued: U.S. Rep. John Yarmuth (D-CA-43) spoke to WEP/GPO. This was followed by a report by **Barb Pretzer of Manhattan, KS, chair of the NARFE Alzheimer's National Committee** reported NARFE members contribute **\$7,590,279**, well on the way to the current target of **\$8 million**. Pretzer said the Committee voted to make the next goal **\$9 million by 2011**. **Harry Johns, President/COO of the Alzheimer's Assoc. applauded NARFE members.**

Sept 9th— Delegates voted to discontinue new Honorary Life Memberships (does not effect those currently Honorary Life Members); established new category 'Distinguished Member'— a member reaches 85 years and no less than 20 years in NARFE—continues to pay NARFE dues—will rec've Distinguished Member pin & ID card. Allow National Executive Board to choose the National Convention sites; also sent a proposal for 'NARFE dues' to a ballot vote; a total of 38 resolutions were submitted; the committee combined many; amended one resolution for passage and recommended rejection of the rest.

Baptiste: Association is faithfully fulfilling its mission; Treasurer Ostergren: NARFE is 'financially stable'; Secretary Brown called for more aggressive 'Lapsed Member Mailing'. Treasurer's Pay Raise went to Ballot to equalize with National Secretary.

Sept 10th - Baptiste re-elected by Acclamation; three NARFE members seek office of **National VP—Joseph Beaudoin, Region X VP; Dan C. Galvan, former National VP; Kenneth Nolan, Mass. Fed VP.** Two candidates competed for **Nat Secy**—Nat Brown current Nat Secy; and Tom McKinney, financial professional. Three way race for Nat. Treas.—Clyde Jeffcoat served as Nat. Pres of the Assoc. of Govt Accts; Richard Ostergren current Nat NARFE Treas; and Richard Strombotne—outlined ideas to increase revenue without increasing dues.

Sept 11th— National President Baptiste led delegates in commemorating the September 11th terrorist attacks seven years ago. Delegates rose and sang 'God Bless America'. Newly elected Nat. officers made their acceptance speeches. Nat Pres. Baptiste gaveled an end to the Convention just before noon.
