As members of NARFE we have a mission as well. There is a constant battle against those who would reduce or take away some of the benefits that we were promised when we accepted employment in the Federal work force. Over the years we have successfully fought many battles and won because we were unified in our efforts.

The greatest battle that we here in North Carolina undertook was when we decided to challenge the taxation of our annuities. During this effort our membership grew and the attendance at our then meeting place was almost standing room only. WHAT HAPPENED? once we received our illegally collected tax refund (with interest) many must have thought that there was no need to attend meetings or be members any longer. I have asked many why they felt they were no longer needed or they did not need NARFE any more. No reasonable answer has been given yet.

The North Carolina Federation over the past two years has had the most open and positive leadership working to help each chapter to be

the very best, our National Office and our lobbyist are working daily on Capital Hill to keep us informed of any possible threats to our benefits. Due to their efforts we have not lost any benefit in the last 12 years, but there are those who are trying to pass more of the cost of health insurance on to retirees, seeking to change from high 3 to high 5 in calculating our annuities, reducing COLAS and the list goes on.

Premium Conversion could pass this session of congress as could the repeal of GPO/WEF and the Homestead Act in North Carolina which could freeze increases in real estate taxes for those age 70 or over. As you can see there is much yet to get done. Be an active part of this mission and contact the members of congress and the senate plus state representatives during the August recess, ask for their support in these areas.

Remember a ragtag group with a mission founded THE UNITED STATES OF AMERICA, the Greatest Nation in the world.

NEW NC FEDERATION OFFICERS

The 2007 Federation Convention elected a new slate of officers for the coming year.

President: Paul Carew, a member and past president of the Chapel Hill chapter 2108, was elected Federation President. Paul was born in Newark, New Jersey and grew up in the Jersey Shore area. He received his A.B. degree from Monmouth University and earned his Masters and Ph.D. from the University of Southern California. Paul served in the U.S. Army in the Korean conflict.

Paul spent 38 years as a civilian employee of the Department of Defense and was a charter member of the Senior Executive Service. He retired from government service in 1996 and moved from Washington D.C to Ferrington Village near Chapel Hill.

Paul is married to the former Amelia Cox Macy and they have four children and two grandchildren.

Executive VP: Elaine Hughes, who served the last two years as Federation executive secretary was elected to the Executive Vice President position. She is well known in the chapters and Federation.

Executive Secretary: Gracie Couch from Rocky Mount Chapter 0781 was elected Federation Executive Secretary. Gracie has a degree in accounting and a degree in Government Accounting as well as completing training at the American Institute of Banking, Time Management and the Institute of Government. She retired from the U.S. Postal Service.

Treasurer: Our new treasurer is Sam Crain. He is from Area III and I do not have his biographical sketch yet but look forward to reading it in the next edition of the Federation newspaper.

NC LEGISLATIVE UP-DATE

Homestead Act: The committee on Ageing of the NC House of Representatives held hearings in May and June on the proposed Senior Homestead Tax Relief act, House Bill number H.B. 1917. This is a proposal backed by NARFE and both hearings were well attended by NARFE members. The second hearing received approval by the committee and, as required, was moved to the budget committee before it goes to the Senate. I spoke with Representative Bordsen from Mebane, a sponsor of the bill, and she informed me that county commissioners would be offered a chance for comments on this bill.

Basically, The Senior Homestead Tax Relief Act requires a county tax value assessment to be frozen at the value at the time the homeowner is seventy years old and has occupied the property as the primary residence for at least 5 years. Subsequent tax valuations may increase the value but taxes would be assessed on the locked-in value in effect at age 70.

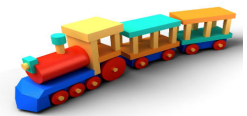
Bailey/Patton: The Bailey/Patton act that gave us our exemption from State income tax on our annuities is before the assembly again to correct the wording in the original act. The new bill will allow the tax exemption for employees who did not have five years of federal government service prior to 1985. There was a discrepancy

in the committee vote count so the hearing was postponed until the next committee meeting.

WE CARE

Alzheimers: Our chapter has been an active supporter of Alzheimer research with our 50/50 drawings at each meeting. You can be proud of our contribution to finding a cure for this insidious disease that threatens all of us.

Toys For Tots: Right in our community we see families who struggle to provide the bare necessities for their children. SERVICE OFFICER REPORT:

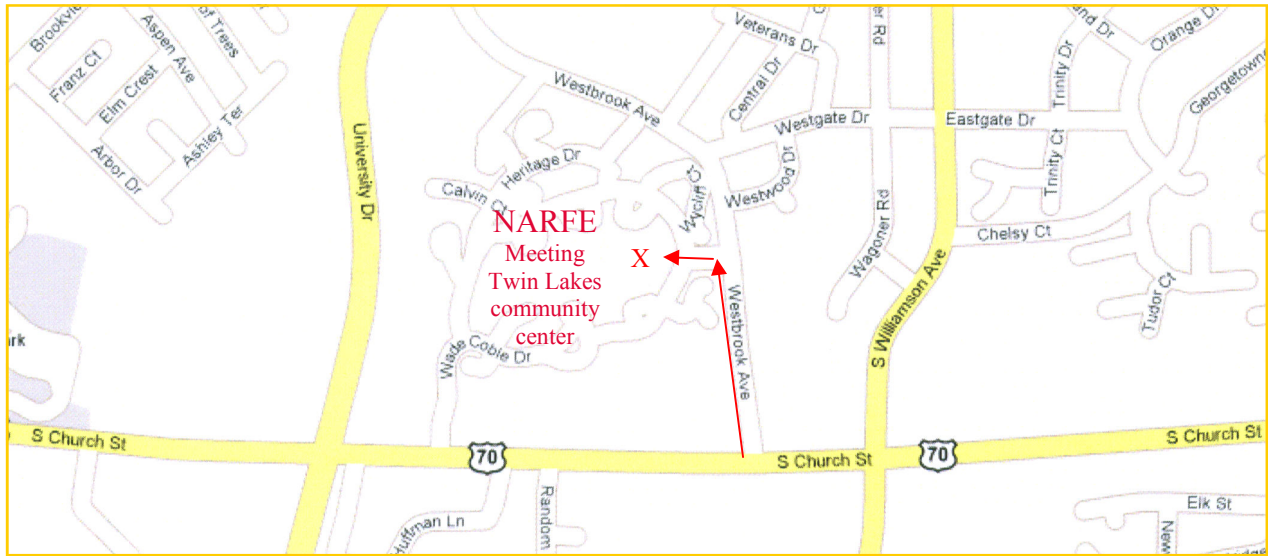
