### NARFE National Dues Referendum Falls Short

The national referendum to standardize chapter dues across all chapters failed to garner enough votes to pass. National President Margaret Baptiste's memo follows:

*December 9, 2009*

*To: Federation Presidents, Chapter Presidents & Chapter Secretaries*

*Subj: NARFE Dues Referendum:*

*Our members have spoken: 65.41 percent voted for, and 34.59 percent voted against. Having failed to receive the necessary two-thirds majority of votes cast, the referendum was defeated.*

*We mailed 1,508 ballots to our chapters and delegates-at-large. Out of this total of 1,508, 224 ballots were invalid (wrong number of votes, no signatures, etc.), and 256 ballots were not returned.*

- The Area IV officer training session will be January 14<sup>th</sup>, 2010 at the NC Club in Raleigh. He would appreciate any suggestions concerning topics that should be included in the session
- Chapter audits have to be completed each year and the results recorded on an F-131.
- Concerning the future of the Chapter in light of the fact that have been no volunteers yet to serve as President, Vice President, and Secretary, there are several options:
  - `Get volunteers for the offices. One way to get volunteers to serve would be to reduce the frequency of Chapter meetings from monthly to bi-monthly or quarterly.
  - Rotate presiding officers at each meeting. This still requires having someone listed on the F-7 as chapter president since the National by-laws require that there is a president.
  - With no President, there is no Chapter.
