## **What does being a NARFE member really mean to me?**

---

NARFE's pledge to you is to always work on behalf of active and retired federal employees and their interests. In order to do this, your membership is vital to the organization, because members provide the strength needed to accomplish NARFE goals. So the greater our membership, the greater our influence in achieving our goals. Currently, NARFE is a network of approximately 1560 chapters, 50 state Federations, and chapters in the District of Columbia, Panama, Philippines, and Puerto Rico.

## **Where am I in the organization?**

---

You've joined other members who reside in North Carolina and make up the NC Federation of Chapters. You have been assigned to a chapter based on your zip code. Your chapter is one of 44 active chapters across the state which are divided among 6 "Areas". Chapters are primarily the greatest source of information for our members. Chapters vary in size and meeting schedules and are governed by both elected and appointed officers. Chapters are your first line of contact and are there to welcome and acquaint you to NARFE and with other community activities and services.

## **How are the NC Federation of Chapters and NARFE governed?**

---

The Federation is governed by an executive board made up of both elected and appointed officers. In addition, NARFE nationally is also governed by an executive board made up of elected officers. It is primarily the responsibility of these boards to communicate with chapters and keep them informed of activities relating to national and state legislation, membership recruitment and retention, and various other federal retiree issues. Chapters provide leadership at the local level and work with our state and national elected representatives to achieve our goals.

## **What Benefits are available?**

---

As a new member, you will soon receive the monthly magazine and the Federation newspaper. Both will keep you informed about NARFE activities, nationally and statewide. Many of our chapters publish newsletters which highlight chapter activities. ## **How am I Represented by NC Federation of Chapters?**

The Federation vigorously supports and works toward NARFE's nationally mandated goals Protecting your earned benefits.

As a federal retiree living in NC, and if you had five or more years of creditable service on or before August 12, 1989, your annuity is exempt from NC state income tax, the result of the very successful Bailey/Patton Settlement of 1998. The NC Federation is supporting efforts to include all federal retirees under this Settlement.
